

RE: Amendment Regarding Membership on the Natural Resources Board
DATE: November 8, 2007

Attached to this memorandum is a copy of WLC: 0161/4, an amendment to 2007 Assembly Bill 504. *Assembly Bill 504* relates to changing the authority to appoint the Secretary of Natural Resources. Under current statutes, appointment is by the Governor. Assembly Bill 504 shifts appointment authority to the Natural Resources Board.

The *current statutes* require that at least three of the seven members of the Natural Resources Board must be from the territory north, and at least three members must be from the territory south of the line running east and west through the south limits of Stevens Point. Board members serve staggered six-year terms, and the terms end on May 1 of the odd-numbered year.

The attached *draft amendment* creates two new qualifications for members of the Natural Resources Board. Each requirement applies to individuals who are members of the Natural Resources Board on May 1, 2014 and thereafter. The 2014 date for full implementation of these requirements will allow extra time for the nomination and approval process, beyond the four years needed for a full cycle of board members (2009, 2011, and 2013):

- At least one member of the Natural Resources Board must have an agricultural background and must be selected from a list of names submitted by statewide agricultural organizations.
- At least three members must have held a sports license or a conservation patron license in at least seven of the previous 10 years and must be selected from a list of names submitted by statewide organizations that are primarily interested in supporting hunting, fishing, or trapping. A sports license is a combination of the small game hunting license, fishing license, and deer hunting license. A conservation patron license encompasses many more individual licenses.

I will submit the amendment to the Legislative Reference Bureau for drafting.
