134.655 Cigarettes; nicotine prohibited. (1) In this section, "cigarette" has the meaning given in s. 139.30 (1m).

(2) No person may sell to a person in this state a cigarette that contains nicotine.

3) Any person who violates this section is subject to a fine not to exceed \$10,000.
