Under current law, a Court Commissioner may collect a fee of \$15 to execute an order and to conduct a supplemental hearing. An attorney from Rep. Molepske's district said this \$15 fee was established in the late 70's or early 80's, and now the fee amount is out-of-date. Rep. Molepske would like to draft legislation that changes this fee from \$15 to \$50. This fee is referenced in Wis. State Statute 816.035(2) and 814.68(2).
