Hi Marlene. As we were reviewing AB 538, we noticed one drafting concern that we'd like to ask Rep Musser to consider amending. I didn't prepare a formal technical memo on this, when I did the fiscal estimate, but this particular language would give us some problem to administer.

The language is on page 2 of the bill, line 8, and on page 3 of the bill, line 6. There is also a reference on page 2, line 17.

These three references require DOT to "affix to each plate" that we issue in certain circumstances the 2 decals for the Red Arrow Brigade or Division.

I don't know if Rep Musser is aware that our plate ordering and mailing process is completely automated, and we don't process any plates/ mailing by hand. In all circumstances we send a plate and the proper decals to the registrant, with instructions on where on the plate to place the decals. This is all done automatically when the plate is ordered.

By requiring us to attach the decal to the plate, the bill would require us to pull these plates out of the automated plate ordering process, attach the decals, return the plates to the envelope and hand-write a mailing label.

Because we issue very few National Guard plates on an annual basis, this workload is not so great as to require added FTE positions in DMV. However, it does create a manual process different for this particular circumstance than for any other plate that is ordered, and as a manual process risks some possibility of error that is not present in the automated process.

We would appreciate if Rep Musser would consider amending the bill to eliminate the specific direction to "affix to each plate" the Red Arrow decals. I'd be glad to answer any questions you have about this. Thank you very much.
