### "Section 7g. Nonstatutory provisions.

(1) Notwithstanding section 16.42 (1) (e) of the statutes, if this subsection takes effect in fiscal year 2008–09, in submitting information under section 16.42 of the statutes for purposes of the 2009–11 biennial budget bill, the department of transportation shall submit information concerning the appropriation under section 20.395 (5) (cq) of the statutes as though the total amount appropriated under section 20.395 (5) (cq) of the statutes for the 2008–09 fiscal year was \$28,600 less than the total amount that was actually appropriated under section 20.395 (5) (cq) for the 2008–09 fiscal year.

#### SECTION 7r. Fiscal changes.

(1) In the schedule under section 20.005 (3) of the statutes for the appropriation to the department of transportation under section 20.395 (5) (cq) of the statutes, as affected by the acts of 2007, the dollar amount is increased by \$28,600 for the fiscal year in which this subsection takes effect to increase funding for special registration plates for members or former members of the 32nd "Red Arrow" Brigade or Division.".
