1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 10: after that line insert:

3 “(c) An ordinance that relates to land use planning or the use of real property
4 may not be published as a notice of an ordinance under this subsection and shall be
5 published in its entirety.”.

6 **2.** Page 4, line 8: after that line insert:

7 “(c) An ordinance, rule, or order that relates to land use planning or the use of
8 real property may not be published as a notice of an ordinance, rule, or order under
9 this subsection and shall be published in its entirety.”.

10 **3.** Page 5, line 3: after that line insert:

11 “(c) A resolution, motion, ordinance, or action that relates to land use planning
12 or the use of real property may not be published as a notice of a resolution, motion,
13 ordinance, or action under this subsection and shall be published in its entirety.”.
