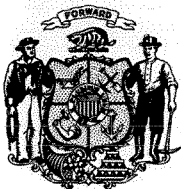

1 AN ACT ...; relating to: littering and providing a penalty. ✓

*Analysis by the Legislative Reference Bureau*

Under current law, the maximum penalty for littering is a forfeiture (civil penalty) of \$500. ✓ Littering includes depositing solid waste on public or private property, other than in a trash receptacle or a solid waste facility, and failing to remove a vehicle from the waters of the state. This bill increases the maximum forfeiture for littering to \$1,000. ✓

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

2 SECTION 1. 287.81<sup>x</sup> (2) (intro.) of the statutes is amended to read:  
3 287.81 (2) (intro.) Except as provided in sub. (3), a person who does any of the  
4 following may be required to forfeit not more than \$500 \$1,000: ✓
