Assembly Bill 590

Rep. Albers – recommendation for amendment change [lrb a0911] to AB 590:

1. Page 2, line 5: after “for” insert “state and”
2. Page 2, line 5: after “at” insert “or in proximity to”.
3. Page 2, line 6: after “state” insert”, including any aircraft conducting operations at or operating in proximity to such installations or bases.”.

Rep. Albers wants to include language that specifies “outside the fence” and “with a weapon” so she suggests the following: “Said employees, if deputized, are authorized to be armed with weapons outside the perimeter of an air base or military installation but limited to the area of jurisdiction of the sheriff who deputized [please reference any statutory connection specific to sheriff’s jurisdiction so we don’t have people armed and roaming about outside the perimeter thinking it’s okay].”
