The Department has the following concern related to the bill:

If enacted in 2007, this bill could first apply to taxable years beginning on January 1, 2008. It is unclear whether this means the credit could first be claimed for 2008 (for degrees awarded prior to 2008, e.g., bachelor degrees awarded in 2005, 2006, or 2007) or if it first applies to degrees awarded in 2008. This should be clarified.
