AN ACT ...; relating to: authorizing hunting of certain game with a crossbow by

nonresidents who have attained the age of 65 years.

## Analysis by the Legislative Reference Bureau

Under current law, the Department of Natural Resources may issue an archer hunting license to any resident applying for the license and may issue a nonresident  $\checkmark$ archer hunting license to any nonresident applying for the license. Both licenses authorize the hunting of certain game with a bow and arrow, including deer.

Current law also provides that a person who has attained the age of 65 may hunt under a resident archer hunting license with a crossbow as well as a bow and arrow. This bill expands this authority so that under a nonresident archer hunting license, a nonresident who has attained the age of 65 may also hunt with a crossbow.

### The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

**SECTION 1.** 29.216 (2m) of the statutes is created to read:

√29.216 (2m) PERSONS 65 YEARS OF AGE OR OLDER. Notwithstanding sub. (2), a nonresident archer hunting license authorizes hunting with a bow and arrow or with a crossbow if the licensee is a person who has attained the age of 65. A person who 2

has attained the age of 65 is not required to hold a permit from the department to

hunt with a crossbow if he or she holds a license under this section.
