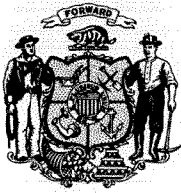

1 AN ACT ^{Gen} relating to: income and franchise tax credits for sales and use taxes
2 paid on nonprescription drugs.

Analysis by the Legislative Reference Bureau

Under this bill, a person may claim an income and franchise tax credit in an amount that is equal to the sales and use taxes that the person paid in the taxable year on the purchase of nonprescription drugs.

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 71.05 (6) (a) 15. of the statutes, as affected by 2007 Wisconsin Act
4 20, is amended to read:
5 71.05 (6) (a) 15. The amount of the credits computed under s. 71.07 (2dd), (2de),
6 (2di), (2dj), (2dL), (2dm), (2dr), (2ds), (2dx), (3g), (3h), (3n), (3p), (3s), (3t), (3w), (5e),
7 (5f), (5h), (5i), (5j), and (5k), and (5m) and not passed through by a partnership,
8 limited liability company, or tax-option corporation that has added that amount to
