February 20, 2008 - Offered by COMMITTEE ON TAX FAIRNESS AND FAMILY PROSPERITY.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 5, line 3: delete "any amount" and substitute "an amount of at least
- 3 \$20 owed to an ambulance service provider that is".
- 4 **2.** Page 5, line 3: after "for" insert "providing emergency services, as defined
- 5 under 42 CFR 438.114 (a), to the individual and for".
- 6 **3.** Page 5, line 10: delete the material beginning with "Not" and ending with
- 7 "appeal" on line 12 and substitute "At least 30 days prior to certification, the
- 8 ambulance service provider shall send the debtor a notice of the ambulance service
- 9 provider's intent to certify the debt to the department. Prior to certification, the debt
- 10 must be reduced to a judgment or the ambulance service provider must provide the
- 11 debtor reasonable notice and an opportunity to be heard with regard to the debt".
- 12 **4.** Page 5, line 16: delete "after the" and substitute "after all other".
