Hi Joe.

My boss would like to introduce a bill to create a sales and use tax exemption for Continuous Positive Airway Pressure (CPAP) machines. He would like it to mirror the exemption for oxygen and oxygen-related equipment under §77.54(14s).

He heard from a constituent who has sleep apnea that is treated with a CPAP machine when he sleeps. The constituent is upset that he has to pay sales tax on the rental of his CPAP machine.

If you could draft a bill for introduction, it would be greatly appreciated.

I should point out that because of the love between the Assembly and Senate, we do not expect this bill to pass. We could introduce it as a credit in the hopes of seeing action on it, but even then, any hopes would be unrealistic. So, I think we will aim at getting a discussion going and hope to get an exemption included the 2009-2011 budget (like the exemption you drafted for us for non-profit cemeteries last year which got into the 2007-09 budget).

AN ACT ...; relating to: a sales and use tax exemption for continuous positive

airway pressure machines

Analysis by the Legislative Reference Bureau

This bill provides a sales and use tax exemption for continuous positive airway pressure machines that are used for medical purposes by any person who has a prescription for the use of the machine.

Because this bill relates to an exemption from state or local taxes, it may be referred to the Joint Survey Committee on Tax Exemptions for a report to be printed as an appendix to the bill.

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 77.54 (14t) of the statutes is created to read:

77.54 (14t) The gross receipts from the sale of and the storage, use, or other consumption of a continuous positive airway pressure machine that is used for medical purposes by a person who has a prescription for the use of the machine.
