Thanks, Scott. This appears to address a great deal of our concerns but given the late introduction, I still think we're going to have to come in neutral to tomorrow's hearing to make sure our legal counsel and board has review of the bill before putting our stamp of support on it. We will be present to testify tomorrow. The one glitch I see right now is the absence of "or under Current Dental Terminology of the American Dental Association" under section 146.903(2)(a)2...it is worded correctly in the insurance disclosure section but omits the CDT under the provider disclosure section. Again, given the late release, I'm not sure we'll be able to officially support the bill at the hearing tomorrow but I suspect that will be our ultimate position once our board and counsel has time to further digest the details. Per our conversation - I think WSA would be supportive of the oversight/input committee idea you describe. This is a new idea and program, it makes sense to have a mechanism involving the folks responsible for complying to evaluate how difficult compliance is, or how well the system is working.

In the sub, pabe 5, Lines 11-17 - here's where the terminology for Anesthesia billing fits.

The billing system is called the "American Society of Anesthesiologists Relative Value Guide" - as I understand it, this is recognized by Medicare, MA and most (if not all) private payers. Probably phrasing the requirement as "AMA CPT codes and/or the ASA RVG as appropriate" or something like that would ensure you catch everything.
