All of these changes are fine. I would also suggest the following changes. Call me if you have questions.

Page 5, line 1: add "or codes" after "code" for those services that have multiple codes within them.

Page 5, line 2: after your addition already in the simple amendment, add "that the provider expects to perform". This section (page 5, lines 1-2, would then read "The relevant code or codes under the CPT or the AMA, under the current dental terminology of the American dental association, or under the American Society of Anesthesiologist Relative Value Guide that the provider expects to perform."

Page 5, line 4: add "the" before 25.

Page 5, line 4: remove "health care services, diagnostic tests, or procedures relevant to the treatment of particular". This is a drafting error and read literally doesn't provide what we want. Literally this would mean the top 25 CPT codes relevant to each presenting conditions would need to be posted. What we want is the top 25 presenting conditions posted. We need this sentence to read (... for each of the 25 presenting conditions, as specified annually by the department...) There are a few sections in the draft where this needs to be changed.

Page 5, line 18: replace "after" with "which may" and replace "consulting" to "consult". As currently drafted DHFS must consult with the Collaborative before defining presenting conditions. They (DHFS) would prefer this to be an option, not a requirement.

Page 5, line 22-23: replace "health care services, diagnostic tests, or procedures" with "presenting conditions". Same reason as above. This wasn't drafted correctly in the beginning.

Page 5, line 24: replace "health care service, diagnostic test, or procedure" with "presenting condition".

Page 5, line 25: replace "health care service, diagnostic test, or procedure" with "presenting condition".

Page 9, line 21: add "or codes" after "code" again because there may be multiple codes for one procedure.
