1 AN ACT ...; relating to: eligibility for veterans housing loan.

Analysis by the Legislative Reference Bureau

X X Under current law, certain persons are eligible for a veterans housing loan, including persons who have completed 6 continuous years of service under honorable conditions in the army unit of the national guard or in the air unit of national guard. Under this bill, a person who has served under honorable conditions in either unit of the national guard for 6 continuous years or who has served a total of 6 continuous years in the two units of the national guard is eligible for a veterans housing loan.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2 SECTION 1. 45.33 (1) (d) of the statutes is amended to read:

3 45.33 (1) (d) Any person who has completed 6 continuous years of service under
4 honorable conditions in the ~~army or air~~ national guard or in any reserve component
5 of the U.S. armed forces, and who is living in this state at the time of his or her
6 application for benefits.
