# 2007 ASSEMBLY BILL 810

February 15, 2008 - Introduced by Representative MUSSER, cosponsored by Senator SULLIVAN. Referred to Committee on Veterans and Military Affairs.

1 AN ACT <sup>regenerate</sup> to amend 45.33 (1) (d) of the statutes; relating to: eligibility for veterans  
2 housing loan.

### Analysis by the Legislative Reference Bureau

Under current law, certain persons are eligible for a veterans housing loan, including persons who have completed six continuous years of service under honorable conditions in the army unit of the national guard, or in the air unit of the national guard. Under this bill, a person who has served under honorable conditions in either unit of the national guard for six continuous years or who has served a total of six continuous years in the two units of the national guard is eligible for a veterans housing loan.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 45.33 (1) (d) of the statutes is amended to read:

4 45.33 (1) (d) Any person who has completed 6 <sup>continuous</sup> years of service under

5 honorable conditions in the army or air national guard <sup>or in any reserve component</sup>  
6 of the U.S. armed forces, <sup>or in any combination of national guard and reserve component</sup> and who is living in this state at the time of his or her <sup>Component</sup>

Hi Bob,

NOTE

Analysis: Under current law, certain persons are eligible for a veterans housing loan, including persons who have completed six continuous years of service under honorable conditions in the army national guard or the air national guard, or in any reserve component of the U.S. armed forces. The Substitute Amendment eliminates the requirement that the 6 years of qualifying service must be continuous. Further, the Substitute Amendment provides that the six years of service may be in any combination of national guard and reserve component service. The national guard service may be in the army national guard, the air national guard or a combination of the two.

45.33 (1)(d) Any person who has completed six years of service under honorable conditions in the national guard, in any reserve component of the U.S. armed forces, or in any combination of national guard and reserve component service, and who is living in this state at the time of his or her application for benefits.
