Hi Beth,

This amendment is done and you'll have it today. I felt I needed to add language similar to (parts of) 2007 AB-584.

Let me know if you need changes after you've had a chance to review it.

There is an initial issuance fee for "Class B" licenses first issued after Dec. 1, 1997 that must be at least \$10,000 (municipalities can set the fee higher than that if they want, but not lower). See s. 125.51 (3) (e) 2. [which also x-refs def of reserve license]. The annual renewal fee thereafter is \$50 to \$500. Under the bill, the restaurant would have to pay the \$10,000 initial issuance fee - if you want it otherwise, I would have to add a specific statutory treatment to do so - I could do something like the treatments in 2005 AB-484 except applicable to this new exception under par. (w).

Regarding selling a business and transfer of the license, the applicable provisions are found in s. 125.04 (12) (b)


