Chris:

Per our conversation this morning, Representative Bies is requesting a bill draft that relates to the state of Wisconsin No-Call list.

Current policy is: You need to renew your registration two months before it expires to ensure uninterrupted service on the List. For example, if your last day to be on the List is January 1, 2004, then you will need to renew before December 1, 2003. If you fail to renew your registration by that time you may have to wait up to four months for your number to be updated to the List again.

Representative Bies would like to change the law so that if your name is on the no-call list, you don't need to renew. It stays on in perpetuity unless you request your name be taken off.

AN ACT ...; relating to: the directory of residential telephone customers who do

not want to receive telephone solicitations.

Analysis by the Legislative Reference Bureau

Under current law, a telephone solicitor may not make a telephone solicitation to a residential telephone customer who has requested to be included in a directory maintained by the Department of Agriculture, Trade and Consumer Protection (DATCP) and provided to registered telephone solicitors. Currently, if a customer fails to make a biennial request to be included in the directory, the department is required to eliminate the customer from the directory.

This bill eliminates the requirement that a residential customer make a biennial request in order to be included in the directory. Under the bill, DATCP must eliminate a residential customer from the directory if the customer requests to be eliminated from the directory.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 100.52 (2) (b) of the statutes is amended to read:

 $\sqrt{100.52}$ (2) (b) The department shall promulgate rules for establishing, maintaining, and semiannually updating a directory that includes listings of

residential customers who do not wish to receive telephone solicitations made on behalf of telephone solicitors. The rules promulgated under this paragraph shall establish requirements and procedures for a residential customer to request a listing in the directory. The rules shall also require a residential customer who requests a listing in the directory to notify the department on a biennial basis if the residential customer wishes to continue to be included in the directory. The department shall eliminate a residential customer from the directory if the customer does not make the biennial notification requests to be removed from the directory.
