1 AN ACT *to amend* 69.22 (1) (c) and 69.22 (1) (c) of the statutes; **relating to:** the 2 amount chargeable for issuing a certified or uncertified copy of a birth 3 certificate to a nonprofit organization.

Analysis by the Legislative Reference Bureau

Currently, the amount that the state registrar or a local registrar must charge for issuing a certified or uncertified copy of a birth certificate is \$20. This amount was increased from \$12 under 2007 Wisconsin Act 20 (the biennial budget act), and is in effect until July 1, 2010, at which time it is reduced to \$12.

This bill requires that the state registrar or a local registrar charge \$12 for issuing a certified or uncertified copy of a birth certificate to a nonprofit organization, until July 1, 2010.
