

As part of the 2007-2009 State Budget (SB40), the cost of obtaining a copy of a birth certificate was increased from \$12 to \$20 (**See Section 1918k. 6922 (1)(c)**). We are looking at introducing legislation that would allow non-profit organizations to only have to pay the old fee of \$12.

As some background, we have a constituent in our district that runs a non-profit organization that tries to get low-income and homeless people copies of their records in order to make it easier for them to apply for a job, or to qualify for public assistance. This increased cost would be very difficult for this individual to continue his work, therefore we are looking for an exemption that would allow non-profit organizations to obtain copies of vital records for the cost of \$12 (the pre-budget passage amount)

We ask that this request remain confidential. This request is not considered urgent and does not have to be given priority over other pieces of legislation.

**Analysis by the Legislative Reference Bureau**

Currently, the amount that the state registrar or a local registrar must charge for issuing a certified or uncertified copy of a birth certificate is \$20.✓ This amount was increased from \$12 under 2007 Wisconsin Act 20 (the biennial budget act), and is in effect until July 1, 2010, at which time it is reduced to \$12.✓

This bill requires that the state registrar or a local registrar charge \$12 for issuing a certified or uncertified copy of a birth certificate to a nonprofit organization, until July 1, 2010.✓

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

**The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:**
