

Dear Cal:

I have reviewed your FAX. I do not believe that the proposed amendment creating Wis. Stats., Sec. 59.53(2m) is the correct way to go. The proposed amendment seems to be tailored to the Neighbor's Place. It is limited to agencies which have a "substantial purpose providing food to low-income individuals." While it would cover the Neighbor's Place, in my opinion, it would not cover other organizations such as the Women's Community.

If you are going to amend a state statute, I believe that the appropriate statute to amend is Wis. Stats., Sec. 59.53 (3). I would amend that statute to read as follows:

"59.53 (3) Social Service Agencies. The board may appropriate funds for promoting and assisting any community action agency under Sec. 46.30 and any nonprofit social service agency organized under IRS Code 501(c)(3) that has a substantial purpose to provide assistance to low-income individuals and individuals who are the victims of domestic violence and related crimes. The County may also appropriate money for making payments to such nonprofit organizations for capital and operational expenses."
