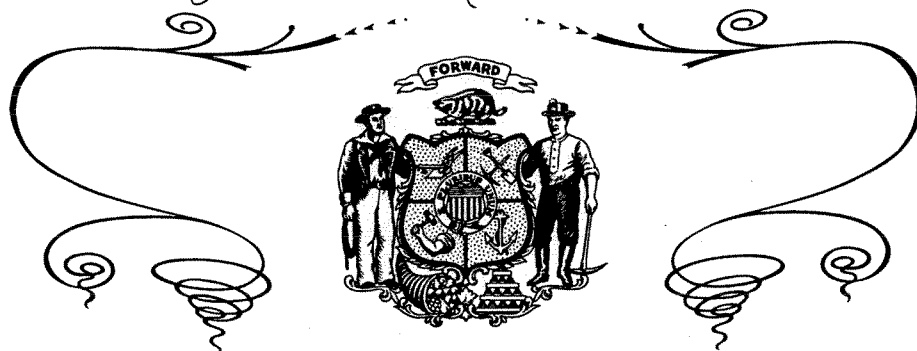

Whereas, Richard Steffens served in the United States Army during World War II where he was awarded the Croix de Guerre, the highest French military decoration of honor, and the American Bronze Star for bravery; and

Whereas, Richard Steffens was a successful and accomplished attorney and served as the city of Menasha attorney for 32 years; and

Whereas, Richard Steffens served in the Wisconsin state assembly for two terms from 1947–1950, representing Winnebago County, second district, where he authored Wisconsin's first antipollution law; and
