


TO 2007 ASSEMBLY RESOLUTION 4

1 At the locations indicated, amend the resolution as follows:

2 1. Page 3, line 14: after that line insert:

3 "SECTION 5m. Assembly rule 56 (1) is amended to read:

4 ASSEMBLY RULE 56 (1) Any member who desires to speak in debate or submit
5 any matter to the assembly shall rise in his or her assigned place and respectfully
6 address the presiding officer. Upon being recognized, the member shall confine his
7 or her remarks to the question before the assembly and shall avoid personalities. A
8 member may be recognized or addressed only by the number of the member's district
9 or; by the county or municipality in which the member resides; by the member's first
10 and last name; or by the member's last name preceded by "Representative." The
11 presiding officer may specify which form of recognition or address is appropriate at
12 any time."
