2 **1.** Page 2, line 1: after that line insert:

3 **"SECTION 1h.** Assembly rule 11 (12) is created to read:

4 ASSEMBLY RULE 11 (12) A committee may not hold a public hearing on a draft
5 proposal prepared by the legislative reference bureau that has only been assigned
6 a number by the legislative reference bureau and that has not been introduced or
7 offered."

8 **2.** Page 2, line 2: delete **"SECTION 1"** and substitute **"SECTION 1p"**.
