5 "SECTION 1m. 15.34 (2) (a) of the statutes is amended to read:

6 15.34 (2) (a) The natural resources board shall consist of 7 members appointed
7 for staggered 6-year terms. Upon the expiration of a member's term, the seat that
8 was held by the member is vacant."
