Analysis by the Legislative Reference Bureau

As of August 1, 200%, this bill adds one circuit court branch in Calumet County. For further information see the **state** and **local** fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Section 1. 753.06 (4) (a) of the statutes is amended to read:

753.06 (4) (a) Calumet County. The circuit has one branch. Commencing August 1, 2007, the circuit has 2 branches.

SECTION 2. Nonstatutory provisions.

(1) The initial election for circuit judge for branch 2 of the circuit court for Calumet County shall be at the spring election of 200% for terms commencing August 1, 200%, and ending July 31, 201
