1 AN ACT *to amend* 753.06 (4) (a) of the statutes; **relating to:** adding a circuit court  
2 branch in Calumet County. ✓

Analysis by the Legislative Reference Bureau

As of August 1, 2006, this bill adds one circuit court branch in Calumet County. For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

3 SECTION 1. 753.06 (4) (a) of the statutes is amended to read:

4 753.06 (4) (a) Calumet County. The circuit has one branch. Commencing

5 August 1, 2006, the circuit has 2 branches. ✓

6 SECTION 2. Nonstatutory provisions.

7 (1) The initial election for circuit judge for branch 2 of the circuit court for

8 Calumet County shall be at the spring election of 2006 for terms commencing August

9 1, 2006, and ending July 31, 2011. ✓

1 (2) The authorized FTE positions for the circuit courts are increased by <sup>✓</sup>1.0 GPR  
 2 circuit judge position on August 1, 200~~6~~<sup>8</sup>, to be funded from the appropriation under  
 3 section 20.625 (1) (a) <sup>✓</sup> of the statutes, to provide an additional circuit court judge for  
 4 the circuit court branch created by this act.

5 (3) The authorized FTE positions for the circuit courts are increased by 1.0 GPR  
 6 court reporter position on August 1, 200~~6~~<sup>8</sup>, to be funded from the appropriation under  
 7 section 20.625 (1) (a) <sup>✓</sup> of the statutes, to provide one court reporter for the circuit court  
 8 branch created by this act.
