The incorrect cross reference that I believe exists in SB 37 can be found on page 6, line 16. Section 48.66 (5) is amended to require actions under s. 48.658 (2) (b) to be completed. However, s. 48.658 does not exist, and is not created by the bill. Is the correct reference supposed to be to s. 48.687 (2) (b)? Many of the cross-references added throughout the bill are to s. 48.687, and 48.687 (2) (b) could make sense in the context of 48.66 (5).
