**SENATE AMENDMENT ,  
TO 2007 SENATE BILL 43**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1 line 1: after “pointing a” insert “facsimile”.

3 **2.** Page 1, line 3: before that line insert:

4 “**SECTION 1g.** 941.20 (1m) (a) 2r. of the statutes is created to read:

5 941.20 **(1m)** (a) 2r. “Facsimile firearm” has the meaning given in s. 941.2965  
6 (1).”.

7 **3.** Page 1, line 3: delete “**SECTION 1**” and substitute “**SECTION 1r**”.

8 **4.** Page 2, line 1: after “points” insert “a facsimile firearm”.

9 **5.** Page 2, line 2: delete the material beginning with “any object” and ending  
10 with “a firearm” on line 3.
