Analysis by the Legislative Reference Bureau

The Office of the Commissioner of Insurance ✓ administers the state life insurance fund (fund). ✓ The fund may issue any type of life insurance policy, with a limit not exceeding \$10,000, to a state resident. Premiums are paid into the fund ✓ and net profits are distributed annually among policyholders. ✓ The state is not liable for any obligation of the fund. This bill increases the limit on a life insurance policy that may be issued by the fund from ✓ \$10,000 to \$20,000. ✓ ✓

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 607.02 (2) of the statutes is amended to read:
4 607.02 (2) LIMITS ON POLICIES FROM FUND. No policies may be issued on any one
5 risk exceeding \$10,000 \$20,000 for residents of this state.
