1. Senate Amendment ___ to Senate Bill 150: replace lines 5-6 on page 14 of the bill with "(1) This act takes effect on January 1, 2009."
2. Senate Amendment ___ to Senate Amendment ___ (LRBa1020/1) to Senate Bill 150: replace lines 11-12 on page 3 of LRBa1020/1 with "**SECTION 70d. Effective dates.** This act takes effect on January 1, 2009." In addition, replace "April 1, 2011." on line 16 of page 3 of LRBa1020/1 with "January 1, 2010."
