Section 52. 101.123 (3) (M) of the statutes is created to read:

101.123 (3) (m) All retail tobacco shops.

Note: If there is a need to define the term "retail tobacco shop" this could be a guide:

"Retail tobacco shop" means a retail establishment that (i) holds itself out to the public as being devoted primarily to the on-site sale of tobacco, tobacco products and tobacco products accessories, and (11) derives not less than 50% of its total annual gross income from the on-site sale of tobacco, tobacco products and tobacco product accessories. If a tobacco shop is located in an enclosed shopping mall, a hotel or any other building used for multiple purposes or if it shares premises with another business, the tobacco shop shall be completely enclosed and separately ventilated.
