6 **SECTION 50m.** 101.123 (3) (m) of the statutes is created to read:

7 101.123 (3) (m) A place of employment operated by a tobacco leaf dealer or  
8 processor.

9 **SECTION 50r.** 101.123 (3) (n) of the statutes is created to read:

10 101.123 (3) (n) A tobacco storage facility."
