3 "SECTION 4m. 115.762 (3) (k) of the statutes is created to read:

4 115.762 (3) (k) Developing and periodically updating a brochure describing the
5 activities that a parent of a child with autism may engage in at home with the child
6 to complement the child's treatment or individualized education program. In
7 developing the brochure, the department shall consult with special education teachers,
8 parents of autistic children, physicians, and representatives of organizations that
9 advocate for the interests of children with disabilities. The division shall distribute
10 the brochure to local educational agencies and physicians."
