Hi Debora,

Per our conversation...

If an employer pays less than 80% of an individual's monthly insurance premium, the individual can qualify for BadgerCare. It is my understanding, through my conversation with the Fiscal Bureau, that the DHFS does not track how many people enrolled in BadgerCare have an employer who contributes to monthly insurance premiums. Senator Roessler would like a bill drafted to require DHFS to track this information. For example, the Department should know if an employer contributes 0%, 20%, 75%, etc. to an individual's monthly insurance premium. According to the Fiscal Bureau, employers are asked the general question, "Do you pay less than 80% of an individual's monthly insurance premium?"

\* Under current law, a family may be eligible for coverage under Badger Care if, among other things, the family has access to coverage under a group health insurance plan offered by an employer for which the employer pays less than 80 percent of the cost, excluding any required deductibles or copayments.

\* This bill requires the Department of Health and Family Services (DHFS), which administers Badger Care, annually to determine, for Badger Care recipients who have access to coverage under group health insurance plans offered by employers, the actual percentages of the insurance plan costs that are paid by the employers. DHFS must report its findings annually in a report to the joint committee on finance and to the appropriate standing committees of the legislature. \*
