The people of the state of Wisconsin, represented in senate and assembly, do Lenact as follows:

753.06 (4) (a) of the statutes is amended to read:

753.06 (4) (a) Calumet County. The circuit has one branch. Commencing

August 1, 2008, the circuit has 2 branches.

Section 2. Nonstatutory provisions.

The initial election for circuit judge for branch 2 of the circuit court for

Calumet County shall be at the spring election of 2008 for terms commencing August

1, 2008, and ending July 31, 2014. (end ins)
