Senator Kanavas would like a bill drafted that would give every voter the option to mark their name on the voter roll as "Photo ID Required." From that point forward, any time an individual attempts to vote with that person's name and address, the poll worker must ask for a photo ID in order for the person to be able to vote. This bill serves as vote theft protection for the voter. The program should be strictly voluntary. In addition, all voter registration cards should contain an "opt in" line allowing voter to indicate they would like to participate in this program. A voter currently registered should visit their municipalities in person to indicate their desire to participate in the program and provide photo ID and signature upon making the request.
