SENATE AMENDMENT 3

Page 2, after line 16 insert

“8. A contract for the lease or purchase of access service, as defined in 196.01(1b), or to lease equipment or facilities used with such service.

9. An interconnection agreement, as defined in 196.01(3) and any contract or agreement offered by a telecommunications utility, as defined in 196.01(10), to meet obligations as provided in the federal 1996 Telecommunications Act, 47 U.S.C. 251 et seq., including 47 U.S.C. 251.

Page 3, line 10, delete the words “30 days” and substitute “one month.”

SENATE AMENDMENT 4

Page 4, after line 15 insert

“(3m) If the seller fails to provide the notice under sub. 4, the contract shall continue on a month-to-month basis and the customer shall have the right to cancel and terminate the contract at any time. In such event, the customer shall remain obligated to pay the seller the monthly service fee under the original agreement, or if a monthly service fee is not included in the original agreement, the customer shall pay seller the *pro rata* portion of the original term's payment obligation.”

SENATE AMENDMENT 5

Page 6 line 2 delete “7th” and substitute “12th”

SENATE AMENDMENT 6

Chris, with this amendment the intent is to exempt telecommunications contracts provided the contract provides the customer with the ability to get out of the contract, or the renewed contract, by paying a fee – either a set amount or pro-rated amount.

Page 2, after line 16 insert something like:

10. A contract for the lease or purchase of telecommunication service, as defined in 196.01(9m), including commercial mobile service, as defined in 196.01(2i), or to lease equipment or facilities used with such services provided the contract provides the customer with the ability to terminate the renewed contract upon payment of a fee equal to
