SENATE AMENDMENT J TO 2007 SENATE BILL 228

At the locations indicated, amend the bill as follows:

JOINT LEGISLATIVE COUNCIL PREFATORY NOTE: 2007 Senate Bill 228 establishes registration requirements for contractors and subcontractors and related prohibitions. This amendment exempts "handyman" contractors from the requirements and prohibitions of the bill.

1. Page 6, line 6: after that line insert:

"101.9945 Exception. Sections 101.992 and 101.993 do not apply to a person who performs, for compensation, miscellaneous small or routine construction activities and who does not employ any other person to perform construction activities.".
