The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

INSERT ANALYSIS

Current law provides that if two or more persons are hunting in a group and each of those persons holds a deer hunting license and is hunting with a firearm, then one of the members of the group may kill a deer for another member of the group under certain circumstances. Those circumstances require that the person who kills the deer must be in contact with the person for whom the deer is killed and the person for whom the deer is killed must possess a current unused deer carcass tag authorized for use on that deer.

This bill authorizes certain persons hunting in a group with a bow and arrow to also/kill a deer for another member of the group. Under the bill, if two or more persons are hunting in a group and each of those persons holds a deer hunting license and is hunting with a bow and arrow, then one of the members of the group may kill a deer for another member of the group if that deer is an antlerless deer. As with the restrictions on group deer hunting with firearms under current law, a member of a group deer hunting party using bows and arrows who kills an antlerless deer for another member of the group must be in contact with the person for whom the antlerless deer is killed and the person for whom the antlerless deer is killed must possess a current unused deer carcass tag authorized for use on that antlerless deer.
