SENATE AMENDMENT,
TO 2007 SENATE BILL 283

1 At the locations indicated, amend the bill as follows:

2 1. Page 3, line 11: after "\$500" insert "for each day of violation".

3 2. Page 3, line 19: delete lines 19 to 21 and substitute:

4 "50.034 (8) (a) Whoever violates sub. (5m) or (5n) or rules promulgated under
5 sub. (5m) or (5n) may be required to forfeit not more than \$500 for each violation.

6 Whoever violates sub. (3m) may be required to forfeit not more than \$500 for each
day of violation.

8 3. Page 4, line 4: delete lines 4 to 6 and substitute:

9 "50.035 (11) (a) Whoever violates sub. (4m) or (4n) or rules promulgated under
10 sub. (4m) or (4n) may be required to forfeit not more than \$500 for each violation.

1 Whoever violates sub. (10m) may be required to forfeit not more than \$500 for each
2 day of violation.
