

1 AN ACT ...; relating to: ~~2002~~ releasing a person convicted of certain offenses

Analysis by the Legislative Reference Bureau

Under current law, a trial judge has discretion to release a person from imprisonment after the person is convicted but before the person is sentenced or granted probation.

Under this bill, if the person has been convicted of a Class A felony or a Class B felony that involved sexual assault, a trial judge may not release the person from imprisonment before sentencing or the granting of probation.

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2 SECTION 1. 969.01 (2) (c) of the statutes is amended to read:

3 969.01 (2) (c) In felonies, release may be allowed upon appeal in the discretion
4 of the trial court. This paragraph does not apply if the person was convicted of a Class

5 A felony or a Class B felony under s. 940.225, 948.02, or 948.025.
