Notwithstanding section 448.78 (3) to (5) of the statutes, as affected by this act, the dietitians affiliated credentialing board may grant a license under section 448.78 of the statutes to a person who no later than the first day of the 13th month beginning after the effective date of this act provides sufficient evidence to the dietitians affiliated credentialing board that the person holds a valid certificate from the dietitians affiliated credentialing board or is currently registered as a registered dietician with the commission on dietetic registration of the American Dietetic Association.

This bill makes a number of changes to the regulation of dietitians.

\leftarrow Licensure and use of titles γ

Under current law, a person may be certified as a dietitian by the Dietitians

Affiliated Credentialing Board in the Department of Regulation and Licensing (board). With certain exceptions, current law prohibits a person who is not certified by the board from designating him or herself as a dietitian, claiming to provide dietetic services, or using any title or initial that would represent that person as certified or licensed as a dietitian or in a nutrition-related field.

"Dietitian" is defined under current law as an individual who practices dietetics, which is defined to mean the integration and application of principles from nutrition science, biochemistry, food systems management, and other fields in order to achieve or maintain the health of an individual or group of individuals. "Dietetics" is further defined under current law to include assessing the nutritional needs of an individual or group of individuals; establishing priorities, goals and objectives to meet those nutritional needs; and providing nutritional counseling.

This bill changes the definition of "dietitian" to mean a person who practices dietetics and nutrition care services. The bill defines "dietetics and nutrition care services" to mean the integration and application of principles derived from the sciences of food, nutrition, management, communication, biology, physiology, behavior, and the social sciences to achieve and maintain optimal human health. The bill defines the "practice of dietetics and nutrition care services" to exclude the retail sale of food products or vitamins, but to include: 1) the assessment of the

nutritional needs of an individual or group of individuals; 2) establishing priorities, goals, and objectives to meet these nutritional needs; and 3) medical nutrition therapy. The bill defines "medical nutrition therapy" as nutritional diagnostic services, therapy, and counseling services provided for the purpose of managing disease.

The bill directs the board to license, not certify, dietitians. The bill prohibits a person who is not licensed from practicing dietetics or nutrition care services. The bill also prohibits, with certain exceptions, a person who is not licensed the board from using any of the following titles or initials: dietitian, certified dietitian, licensed dietitian, nutritionist, certified nutritionist, licensed nutritionist, dietitian nutritionist, certified dietitian nutritionist, licensed dietitian nutritionist, nutrition consultant, nutritional consultant, L.D., L.N., L.D.N., or any title or initials that may tend to represent that the person is certified or licensed as a dietitian or in a nutrition–related field.

Requirements for licensure by the board.

To be certified as a dietitian under current law, a person must do all of the following:

- 1. Receive a bachelor's, master's, or doctoral degree in certain fields, including human nutrition, nutrition education, and food system management, received from a college or university that the board determines is regionally accredited. If the college or university is not located in the United States, the program must be substantially equivalent to a program offered by a regionally accredited college or university. Alternatively, a person may receive a degree from a program approved by the board.
 - 2. Complete at least 900 supervised hours of dietetics practice.

Current law exempts a person who is licensed or certified and lawfully

In other words, we request that the paragraph should read as:

The term validated in the statute could be defined in the regulations; however, we believe we have a simpler solution. Applicants who apply to the Dept. of Regulation

and Licensing for a license, reciprocal license or temporary license will have had to demonstrate validity of their academic degree with CDR already; CDR requires this before providing a letter verifying registration eligibility status (pre-exam) or granting a "registered dietitian" credential (post-exam).

With this in mind, we suggest that the wording of 448.78 (3)(b) be modified as follows:

Possesses a bachelor's, master's or doctoral degree granted by a college or university outside the United States that has been determined equivalent to a degree granted by a United States regionally accredited college or university, as under par. (a).

If we need to define "equivalent", this could be defined in the rules or a glossary, using language from above.

I did not modify s. 448.78 (3) (b) to include the underlined text. However, I did eliminate "a state or territory of" so that the language of this paragraph parallels the language provided by the Association for s. 448.78 (3) (a). Eliminating "a state or territory of" makes perfect sense.

448.72 (9): A person pursuing a supervised course of study, including internships, leading to a degree or certificate in dietetics and nutrition care services from an educational program accredited by the accreditation commission.

with the following more clearly and accurately worded exemption:

448.72 (9): A student enrolled in a dietetics education program accredited by the accreditation commission to meet eligibility requirements to write the registration commission's examination for dietitians.

Page 10, line 13 & 14; 448.74 (1): Reads that the affiliated credentialing board shall . . . establish . . . "Criteria for the approval of educational programs and training under s. 448.78 (3) and (4)." We are not absolutely opposed to this language, but we believe it to be unnecessary. Registered dietitians applying for a license merely need to show proof of registration status with the registration commission as verification that criteria for "approval of educational programs and training under s. 448.78 (3) and (4)" have been met. Certified dietitians who are not registered but are grandfathered in within the first year under 448.78 (6)(a) need only show proof of current certification as a dietitian in Wisconsin. Newly graduated dietitians who have completed their didactic requirements (s. 448.78 (3)) and 900 hours supervised practice (448.78 (4)) need only submit "a letter from the registration commission verifying registration eligibility status" as proof of their eligibility for a temporary license (as spelled out in s. 448.80).

Page 10, lines 16 & 17; 448.74 (1g): Reads that the affiliated credentialing board shall . . . establish . . . "Standards for acceptable examination performance by an applicant for licensure as a dietitian." We oppose this language as we believe it implies the board can make its own interpretations re: failure or passing of the registration commission's registration exam. We

believe the bill would be much clearer if this language were deleted; s. 448.78 (5) already clearly establishes one of the requirements of licensure as "Passes the registration examination for dietitians established by the registration commission."

Page 11, after line 20: It appears as though 448.78 (2) was inadvertently omitted from the "introducible bill." Please re-include:

Page 13, line 8: An additional edit to <u>448.80 Temporary License</u> was inadvertently omitted from the "8.6.07 Edits to Bill" document; "9 months" should be revised to "6 months", so that the end of this section reads:

"... is valid for a period designated by the affiliated credentialing board, not to exceed 6 months, and may be renewed once by the affiliated credentialing board."

Dietetic educators surveyed in Wisconsin agreed that this time will be adequate for the registry eligible dietitian to take and retake the registration exam, as needed. Additional time (9 months) is no longer needed now that dietitian registration exams are administered daily on line in regional testing centers.

Page 14, lines 17-20; 448.86 (3): We propose again wording which resembles that originally requested for this section:

(3) An applicant for renewal of a license granted under this subchapter shall provide proof of Continuing Professional Education (CPE) credits at a level equal to or greater than the requirements of the registration commission by showing proof of current registration status with the registration commission or by submitting the registration commission's Subsequent Approval CPE Reporting Forms for Licensed Dietitians.

Rationale: We cannot require all applicants for license renewal to "provide proof of registration" with the registration commission since a small minority of our licensed dietitians will have been grandfathered in as certified dietitians who were never (or are no longer) registered with the registration commission. (This grandfathering of CDs is spelled out on page 16 of the "introducible bill", in Section 56. Nonstatutory provisions.) Fortunately, "the registration commission" understands the need for continuing education documentation for non-RD licensed dietitians and accommodates this select group by allowing them to pay a small fee and submit for continuing education approval using "the registration commission's Subsequent Approval CPE Reporting Forms for Licensed Dietitians". FYI, all registered dietitians are required to document and submit continuing education records to the registration commission via a more complex yet constructive system referred to as the "Professional Development Portfolio."

Great. Here are my comments and questions:

1. Regarding the Association's request to include ss. 448.78 (2) and 448.94 in the bill:

The association has not requested a change to current law, so neither of these sections need to be included in the bill.

2. Change to title of the Affiliated Credentialing Board governing a dietitian or nutritionist:

Because the title of a licensee will now be "dietitian or nutritionist", I changed the name of the affiliated credentialing board and the title of the subchapter to "Dietetics and Nutrition Care Services Affiliated Credentialing Board." This is consistent with the title of the examining board governing another compound title, "barber or cosmetologist" (a person licensed as a barber or cosmetologist is governed by the Barbering and Cosmetology Examining Board).

3. Title of s. 448.71:

The omission of a title was an oversight on my part -- the title will read "License required."

4. Changes to s. 448.78 (3) (b) regarding degree granted by a college or university that is not located in the United States:

This section will now read as follows:

"Possesses a bachelor's, master's, or doctoral degree granted by a college or university that is not located in the United

States if the registration commission has determined that the degree is substantially equivalent to a degree granted under par. (a)."

Okay?

5. Regarding amendments to the exemption under proposed s. 448.72 (9) for persons pursuing a supervised course of study:

The Association requested that I include the clause: "to meet eligibility requirements to write the registration commission's examination for dietitians".

I wonder whether it is important to include the *reason* that a person is enrolled in a dietetics education program; more importantly, if the person is not enrolled in a dietetics program for that one reason, then that person would need a license under the subchapter. As drafted, I left the clause, above, out, and this provision reads as follows:

"A person enrolled in a didactic program in dietetics accredited by the accreditation commission."

Okay?

6. Examination under s. 448.78 (5):

Does the registration commission prepare registration examinations for any professionals other than dietitians? If not, then I will amend s. 448.78 (5) to strike for dietitians in the clause that reads "registration examination for dietitians". Okay?

Hi Joan-

Here are the latest comments from the drafter of the dieticians licensing bill.

Here are my comments and questions:

1. Regarding the Association's request to include ss. 448.78 (2) and 448.94 in the bill:

The association has not requested a change to current law, so neither of these sections need to be included in the bill.

Understood. Thanks for clarifying.

✓ 2. Change to title of the Affiliated Credentialing Board governing a dietitian or nutritionist:

Because the title of a licensee will now be "dietitian or nutritionist", I changed the name of the affiliated credentialing board and the title of the subchapter to "Dietetics and Nutrition Care Services Affiliated Credentialing Board." This is consistent with the title of the examining board governing another compound title, "barber or cosmetologist" (a person licensed as a barber or cosmetologist is governed by the Barbering and Cosmetology Examining Board).

This is perfectly acceptable.

√ 3. Title of s. 448.71:

The omission of a title was an oversight on my part -- the title will read "License required."

Excellent.

4. Changes to s. 448.78 (3) (b) regarding degree granted by a college or university that is not located in the United States:

This section will now read as follows:

"Possesses a bachelor's, master's, or doctoral degree granted by a college or university that is not located in the United States if the registration commission has determined that the degree is substantially equivalent to a degree granted under par. (a)."

Okay?

While the "registration commission" requires the candidate for registration to validate their degree as described previously, it is true that the commission does not grant the RD credential unless it believes the foreign degree has been shown to be equivalent. So your wording above is okay.

5. Regarding amendments to the exemption under proposed s. 448.72 (9) for persons pursuing a supervised course of study:

The Association requested that I include the clause: "to meet eligibility requirements to write the registration

commission's examination for dietitians".

I wonder whether it is important to include the *reason* that a person is enrolled in a dietetics education program; more importantly, if the person is not enrolled in a dietetics program for that one reason, then that person would need a license under the subchapter. As drafted, I left the clause, above, out, and this provision reads as follows:

"A person enrolled in a didactic program in dietetics accredited by the accreditation commission."

Okav?

This revision is not acceptable for two reasons:

1) It limits exemption to those enrolled in a didactic program whereas it must also exempt those in

a supervised practice or internship.

2) It needs to include the clarification that only those students in a education/training program leading to registration as a dietitian are exempted. The "accreditation commission" also accredits education/training programs for students pursuing a dietetic technician credential, and these students would not be exempted from the licensure requirement.

For these reasons, we request the previously recommended wording, which reads: "448.72 (9): A student enrolled in a dietetics education program accredited by the accreditation commission to meet eligibility requirements to write the registration commission's examination for dietitians."

6. Examination under s. 448.78 (5):

Does the registration commission prepare registration examinations for any professionals other than dietitians? If not, then I will amend s. 448.78 (5) to strike for dietitians in the clause that reads "registration examination for dietitians". Okay?

The registration commission also prepares and administers examinations for dietetic technicians as well as for advanced level practice dietitians, so please leave in the clause "registration examination for dietitians" so that the section reads: "Passes the registration examination for dietitians established by the registration commission."

7. Regarding your request for changes to s. 448.86 (3):

A. I cross-referenced the continuing education requirements established under s. 448.74 (1m); okay? If this cross-reference is not necessary and it is the Registration Commission and the Registration Commission alone that determines what continuing education requirements need to be met, then I would recommend eliminating s. 448.74 (1m). Please let me know what the Association prefers.

Thank you for clarifying that s. 448.74 (1m) is renumbered from the previous 448.74 (1r) and reads:

"448.74 (1m) Continuing education requirements to be satisfied by an individual applying to renew a license under s. 448.86 (3) that substantially conform to the continuing professional education requirements established by the registration commission."

We agree that it is the Registration Commission and the Registration Commission alone that determines what continuing education requirements need to be met and therefore concur that 448.74 (1m) should be eliminated.

b. For persons who can not demonstrate proof of registration with the Registration Commission, are you asking that the bill require the applicant for renewal to submit the Subsequent Approval CPE Reporting Form for Licensed Dietitians itself to the Department, or some sort of subsequent approval received by the applicant (in lieu of proof of registration) from the Registration Commission after the Registration Commission has reviewed and verified that the applicant has completed and accurately reported the appropriate continuing professional education credits?

We are suggesting the latter; i.e., non-RD licensed dietitians shall be required to submit Subsequent

Approval CPE Reporting Forms for Licensed Dietitians to the registration commission, allowing the registration commission to send verification to the WI Dept. of Reg. & Licensing that the LDN has completed and accurately reported the appropriate continuing professional education credits.

With this in mind, the wording previously proposed would be clearer if reworded as follows:

"(3) An applicant for renewal of a license granted under this subchapter shall provide proof of Continuing Professional Education (CPE) credits at a level equal to or greater than the requirements of the registration commission by showing proof of current registration status with the registration commission or by obtaining documentation from the registration commission verifying that appropriate continuing professional education credits have been completed and accurately reported using the Subsequent Approval Licensure Reporting Form."

Thank you for your attention to these details. We eagerly await the revised introducible draft.
