Hi Tracy-

Thanks for the advice.

Go with this option:

"2. Retain s. 448.72 (8) as it exists in the bill and add the following under s. 448.72 (7): A person licensed or certified under [chs.] 441 or <u>447</u> to 451, providing diet, food, or nutrition information within the scope of his or her practice." (emphasis added only for this email)"

If you believe that the phrase "a person lawfully practicing within the scope of a license granted under..." is more clear, and not substantial different in effect, that the other proposed language, we can substitute.

As you know, the intent to make sure that these folks lawfully practicing under the stated statutes that certify or license them, are exempted from having to get a dietician's license if part of their job could be giving nutrition advice to their customers or patients.

Hi Stuart -

If the amendment, "A person licensed or certified under [chs.] 441 or 446 to 451, providing diet, food, or nutrition information within the scope of his or her practice.", is added, I would also amend the bill to eliminate Section 32, which would be duplicative. Most likely I would create the new exemption, above, at s. 448.72 (7), which is the first part of Section 32.

Section 12 is not duplicative and would remain unchanged.

The language applicable to chiropractors under s. 448.72 (8) (in current Section 32) is, obviously, different than the proposed amendment, above. To the extent that you wish to retain that language, there are two options:

1. Incorporate the language from current Section 32 so that the amendment, above, would read as follows:

"A person lawfully practicing within the scope of a license or certificate granted under chs. 441 or 446 to 451."

2. Retain s. 448.72 (8) as it exists in the bill and add the following under s. 448.72 (7): A person licensed or certified under [chs.] 441 or <u>447</u> to 451, providing diet, food, or nutrition information within the scope of his or her practice." (emphasis added only for this email)

To be totally honest, I actually like the language, "a person lawfully practicing within the scope of a license granted

under..." better than the language "providing diet, food, or nutrition information within the scope of his or her practice." Please let me know if the language you propose ("providing diet, food, or nutrition information within the scope of his or her practice.") must remain unchanged or if, in the alternative, I may tweak the language to best achieve clarity in drafting...

Thanks for the email.

Would an amendment work if, in the exemptions sections, the following was inserted:

"A person licensed or certified under Sections 441 or 446 to 451, providing diet, food, or nutrition information within the scope of his or her practice."

If this amendment was added, would the following sections be duplicative?

SECTION 12. 446.02 (6m) of the statutes is amended to read: 446.02 (6m) No chiropractor may provide counsel, direction, guidance, advice, or a recommendation to a patient regarding the health effects of vitamins, herbs, or nutritional supplements unless the chiropractor has been issued a certificate under sub. (2) (c). This subsection does not apply to a chiropractor licensed under this chapter who is licensed as a dietitian or nutritionist under subch. V of ch. 448.

SECTION 32. 448.72 (7) and (8) of the statutes are created to read: 448.72 (7) A physician as defined in s. 448.01 (5). (8) A person who is lawfully practicing within the scope of a license granted under ch. 446, who satisfies the requirements of s. 446.02 (2) (c), and who is lawfully practicing within the scope of the certificate issued under s. 446.02 (2) (c).

Hi Stuart;

Yes, something like this would work.

I don't think the clause "except that the person may not represent himself or herself as a dietitian or nutritionist or any other titles or credentials protected under section....." is necessary, however, because the draft prohibits any person from representing himself or herself as a dietitian or nutritionist unless the person falls within one of several enumerated exceptions (see Sections 28, 29, 30, 31, 37, and 38 of the bill.). Persons exempted from the licensure requirement (proposed below) would not be included in one of those existing exceptions from the prohibition on the use of titles.
