- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 2, line 11: delete lines 11 to 18 and substitute:
- 3 **"(2) RETENTION OF CERTAIN INFORMATION PROHIBITED.** (a) No person that accepts
- 4 an account access device in connection with a sale of goods or services may retain for
- 5 more than 48 hours after the sale is authorized any of the following obtained from
- 6 the account access device:
- 7 1. A security code.
- 8 2. A personal identification number.
- 9 3. The full contents of a magnetic stripe on the access device.
- 10 (b) No service provider may retain any of the following obtained from an
- 11 account access device in connection with a sale of goods or services after the sale is
- 12 authorized:
- 13 1. A security code.
