Chris -

We want to exempt smaller merchants from the bill by placing a 20,000 transaction threshold on the bill. If a merchant has more than 20,000 the merchant is NOT exempt, if the number of transactions using an account access device is 20,000 or fewer in a calendar year the merchant is exempt. We want to make certain this amendment only applies to merchants – not service providers.

We also want to say that the court may award reasonable attorney fees.

This bill is scheduled to be on the floor Thursday, so if we could have this done in one amendment ASAP that would be great.
