AN ACT to renumber and amend 454.10 (3) of the statutes; relating to:

(a) a constant of the constant

supervision of barber or cosmetologist apprentices.

### Analysis by the Legislative Reference Bureau

Under current law, a person may learn barbering or cosmetology through an apprenticeship. No apprentice may practice barbering or cosmetology except under the supervision of a licensed manager. This bill permits a licensed manager to delegate supervisory authority over an apprentice to a licensed barber or cosmetologist who has completed at least 2,000 hours of practice as a licensed barber or cosmetologist.

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 3 Section 1. 454.10 (3) of the statutes is renumbered 454.10 (3) (a) and amended to read:
- 5 454.10 **(3)** (a) No apprentice may practice barbering or cosmetology except 6 under the supervision of a licensed manager <u>or under the supervision of a licensed</u>
