SENATE SUBSTITUTE AMENDMENT, TO 2007 SENATE BILL 523



AN ACT ...; relating to: requesting that an extraordinary session be convened for the purpose of considering legislation related to the Great Lakes Water Resources Compact.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 Section 1. Nonstatutory provisions.

(1) The members of the committee on organization in each house are requested to convene an extraordinarily session, to begin not later than May 1, 2008, for the purpose of considering legislation related to the Great Lakes—St. Lawrence River Basin Water Resources Compact.
