1 **AN ACT** ...; **relating to:** requesting that an extraordinary<sup>✓</sup> session be convened for  
2 the purpose of considering legislation related to the Great Lakes Water  
3 Resources Compact.<sup>✓</sup>

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

4 **SECTION 1. Nonstatutory provisions.**<sup>✓</sup>

5 (1) The members of the committee on organization in each house are requested  
6 to convene an extraordinary<sup>✓</sup> session, to begin not later than May 1, 2008,<sup>✓</sup> for the  
7 purpose of considering legislation related to the Great Lakes—St. Lawrence River  
8 Basin Water Resources Compact.<sup>✓</sup>
